# Program: Arctic Cat Green Track Program – United States



### **Program Summary**

Between December 28, 2024 and March 31, 2025; Qualifying Dealers will be eligible to offer consumer facing rebates on eligible models.

Additional terms and conditions apply.

## **Dealer Qualifications**

To be eligible to participate in the Program, Dealers must:

- 1. Have a current and valid executed Arctic Cat Dealer Agreement authorizing dealer to sell the listed Models above in the Region;
- 2. Dealer has a Wells Fargo floorplan finance agreement in place and in good-standing, with sufficient available credit.

To participate in the Program, dealer must make a Qualifying Retail Sale of an eligible Model to a bona-fide end user.

### **Qualifying Retail Sale**

A Qualifying Retail Sale under the Program must meet the following conditions:

- 1. Dealer has made a retail sale of a qualifying model to a bona-fide end user within the program dates;
- 2. The purchased vehicle is invoiced at or above the Manufacturer's Minimum Advertised Retail Price, before any instore rebate is applied;
- 3. Dealer applies an instant in-store rebate to the bona-fide end user in the amount listed below;
- 4. The vehicle is warranty registered to the bona-fide end user on the final invoice within seven (7) days of the retail sale;
- 5. Units applied for the Demo Program, Units applied for the Rental Program, Units applied for the Commercial Program, or Units purchased on a Discount Program do not qualify for the below rebates.
